If awarded more space and/or a corner, a new balance due invoice will be sent with an acceptance letter.** There is limited availability for space including halves and corners. Please do not combine checks. For each show you are applying to you must send a separate check. Sorry, no credit cards. If any application is not accepted, checks and photos will be returned.

Balance due checks should be post-dated to match the following dates and will be cashed accordingly:

**EXHIBITOR CONTRACT**

1. Exhibitors may not sublet or apportion space to anyone else. No booth sharing.
2. An application is a commitment to show. No refunds will be given after the acceptance notice is sent.
3. A \$50.00 fee will be assessed on any check returned by Exhibitor's bank.
4. Exhibitors may only show work typified by photos submitted.
5. The Exhibitor's booth must be open and staffed during all exhibiting hours. Anyone arriving late, leaving before closing or breaking down during show hours may be asked to leave and not invited back to future shows. All monies forfeited. No refunds.
6. Exhibitor's booth must not interfere with adjacent exhibits in any way.
7. Exhibitor is responsible for any damages caused by exhibitor or exhibitor's display to facility, show property, or another exhibitor's display or property.
8. All Exhibitors are responsible for keeping their area clean during show hours, including final clean-up at the end of the show. All displays should be neat, clean and tables must be covered on all exposed sides.
9. State sales tax for the duration of the show must be paid according to the Michigan of Revenue collection agent's guide sheets by exhibitor.
10. HANDCRAFTERS UNLIMITED ® will not be liable for refunds or any other liabilities whatsoever for the failure to fulfill this contract due to reasons of the location in which show is held before, or during the show if destroyed by fire or other calamity, or by any act of God, public enemy, strikes, statutes, ordinances, or any legal authority, or any cause beyond its control.
11. Exhibitors shall be liable for delivery, handling, erection and removal of their displays and materials.
12. Exhibitors found in violation of any of the items in this contract may be excluded and have their exhibits removed from the current and/or future HANDCRAFTERS UNLIMITED ® shows at the sole discretion of the show manager. No refunds will be provided. Under no circumstances, including negligence, shall HANDCRAFTERS UNLIMITED ® be liable for any direct, indirect, incidental, special or consequential damages resulting from such action.
13. The show manager may require the removal of items considered to be in violation of these conditions and reserves the right to make final interpretation of all conditions.
14. If any section, sentence, clause, phrase or portion of this licensing application/contract is, for any reason, held invalid or unconstitutional by any court or competent jurisdiction, such portion shall be deemed a separate provision and such holding shall not affect the validity of the remaining portions.
15. This contract shall be deemed to have been made in the State of Michigan and shall be interpreted in accordance with the laws of such state. In the event that legal action is required to enforce this contract or any of the terms thereof, such action shall be brought in the Courts of Genesee County, Michigan, and the process is such action by ordinary mail sent to their business addresses.
16. This contract constitutes the entire agreement between HANDCRAFTERS UNLIMITED ®, and the Exhibitor and no modification shall be valid unless in writing and signed by the parties or their representatives.
17. Failure to follow these rules or abusive behavior to show volunteers or employees will result in immediate termination of your participation in the show.
